Throughout 2024 Elder Options championed the needs of older adults, adults with disabilities, and caregivers through impactful programs and advocacy efforts. This fall, our CEO, Katina Mustipher visited policymakers at both the local and state levels to advocate for critical issues facing seniors, including housing, access to care programs, and caregiver needs.

Elder Options provided 9,161 clients with direct services, while 10,259 clients are awaiting services. These numbers highlight the dedication of our staff, volunteers, and community partners. Committed to our mission, we continue to provide trusted resources while adapting to new challenges.

Elder Options is an independent non-profit founded in 1977 and designated by the State of Florida as the Area Agency on Aging/Aging and Disability Resource Center for Alachua, Bradford, Citrus, Columbia, Dixie, Gilchrist, Hamilton, Hernando, Lafayette, Lake, Levy, Marion, Putnam, Sumter, Suwannee, and Union counties.

We provide information and referral services, benefits counseling, screening and eligibility assistance, Healthy Aging workshops on diabetes, classes for improving and maintaining balance (Tai Chi), one-on-one help for depression, SHINE Medicare counseling, and Caregiver Training and Support and we administer state and federal pass-through funds via grants awarded to contracted service providers.



PROGRAM HIGHLIGHTS



Thanks to the generosity of the **Retirement Research Foundation** our Caregiver Training and Support team partnered with 10 community organizations to share resources with vulnerable caregivers. We equipped caregivers with necessary tools to care for themselves and their loved ones.



Volunteers and staff on the SMP team reached 8,294 people, including hosting seven Medicare Fraud Prevention events in June! Since 2021, our team has helped 144 beneficiaries and their families report fraud, correct errors, and prevent abuse, helping protect Medicare for future generations.



Elder Options provides free, evidence-based education on managing diabetes and staying healthy with new diagnoses. With support from the **UF Medical Guild** grant, we now offer tools like glucometers, food scales, and thermometers to help clients monitor their health at home.



Our partnership with **UF Health** helps patients transition from hospital to home by ensuring their needs are met. We assist with medication management, health records, follow-up care, and condition education. Our coaches served 940 patients, with 96% avoiding readmission within 30 days.

SENIOR SUCCESS SPOTLIGHT

Living alone and feeling disconnected, Mrs. Smith longed for support. That changed when she began working with an Elder Options PEARLS (Program to Encourage Active, Rewarding Lives) coach. With one-on-one guidance, she found new ways to stay active, engaged, and hopeful.

"PEARLS opened my mind up to try new things, and look at things in a positive manner. My activities kept me busy and I did not feel alone. I was very encouraged."
